## Registering a death

All deaths must be registered with a Registrar of Births and Deaths in the area where the death occurred. They should be registered within five days unless a Coroner is investigating the circumstances of the death.

### What do I need to do first?

When someone dies, a Doctor issues a medical certificate of cause of death. When you have this certificate, you can make an appointment to register the death.

If the death occurred in Kent you may use Kent County Council's online service at:

Alternatively you can call KCC's contact centre on: 03000 415151.

### Please note:

Kent does not include the Medway Towns (Chatham, Gillingham, Rochester, Strood) or the London Boroughs of Bexley or Bromley. Any deaths occurring in these areas must be registered there. If you are unsure where you need to register please call 03000 415151 for advice.

## Who can register a death?

- A relative
- A person present at the death
- Someone who lives in the house where the person died
- A person arranging the funeral with the funeral director
- A responsible person from the hospital or home where the person died.

## What do I need to take?

- The medical certificate of cause of death issued by a Doctor (if there been a post mortem the Coroner will send this directly to the Registrar)
- If they are available – birth, marriage or civil partnership certificates, which confirm the details to be entered into the death register
- Disabled parking ‘Blue Badge’ if the deceased had one
- A method of payment for copies of the death certificate (i.e. cash, credit/debit card or cheque)

## What happens when I Register?

The Registrar will ask you to confirm the following information:

- The date and place of death
- The full name that the person who died was using at the time of their death
- Details of any other names they might have been known by
- The date and place of birth
- The occupation and whether or not they were retired
- The current home address
- If the person who died was a married woman or widow, her maiden surname (what her surname was before she was

married) and the full name and occupation of her husband

- In the case of a man, the name and occupation of his wife
- In the case of a couple who have registered their civil partnership, the partner’s name and occupation
- Your full name and address and your relationship to the person who has died

The following confidential information will also be required for government statistics:

- Was the person who died single, married, widowed, divorced, a civil partner, surviving civil partner or former civil partner?
- Is their spouse or civil partner still alive? If so, what is their date of birth?
- How long did they stay in hospital or in another establishment (a hospice for example)?
- Was the person under 75?
- What industry did they work in and what position did they hold?
- Did they get a pension paid from government funds? This includes the civil service, teachers, armed forces and war widows. This does not include the state pension or pension credits
- The person’s NHS number found on their medical card (if available)

Once the registration has been completed you will be asked to sign the entry. It is important that the information recorded is as accurate as possible as the correction of errors discovered after the register has been signed may cause delay and inconvenience.

## I want to register the death but I don't live locally

If you do not live in the county where the death occurred, it is possible to give the details to any Registrar in England or Wales. This is known as registering by declaration. The Registrar to whom the declaration is given does not register the death, but will send the information to the Kent Libraries and Registration Service, where it will be registered. You may also order death certificates. A charge is made for these and you will need to have a cheque or postal order with you when you give the declaration. The Registrar will send the order and cheque/postal order to them. Once the death has been registered you will receive all necessary documents by post.

## Do I have to pay a fee?

No. The service is free of charge. However, certified copies of the death entry (death certificate) can be purchased for a small fee. You will need to produce a death certificate when you are sorting out the finances of the person who has died (for example with banks, building societies and insurance companies).

## The Registrar will give you:

- Any certified copies of the death entry that you have paid for.
- A green form to give to the funeral director. If the death has been referred to the Coroner and the funeral is a cremation, the equivalent form will be sent by the Coroner to your funeral director.
- A unique reference number for use with the Tell Us Once Service.

## The Tell Us Once Service

At registration, the registrar will add the details of the deceased to the Tell Us Once national database. After 24hr hours you will be able to contact the service on 0800 085 7308, quote the unique reference number given to you at the registrar and Tell Us Once will notify:

- HM Revenue and Customs (HMRC) - to deal with tax and cancel benefits.
- Department for Work and Pensions (DWP) - to cancel benefits, for example Income Support.
- Passport Office - to cancel a British passport.
- DVLA - to cancel a driving licence.
- The local council - to cancel Housing Benefit, Council Tax Benefit, a Blue Badge, inform council housing services and remove the person from the electoral register.
- Public sector or armed forces pension schemes - to stop pension payments.

## The Coroner

When a death occurs in the following circumstances it will be referred to the Coroner:

- The death is sudden and unexpected
- The cause of death is industrially related
- The cause of death is unknown
- There are suspicious circumstances surrounding the death
- When a Doctor has explained that he/she is unable to issue a medical certificate of cause of death.

## Funeral Ceremonies

The funeral service is an important time when family and friends will be focussing their thoughts on the person who has died. It should help them to express and share their sadness but also to celebrate the life that was lived.

People committed to a religious faith will normally want a religious minister or leader to conduct their funeral ceremony. But there are other options for those for whom religion is less important.

The length of the service will depend on what is included in the ceremony, the type of funeral and where the ceremony is taking place. However, as a guide, crematorium service times last for around 30 minutes. This might be insufficient, please speak to your funeral director who will be able to arrange for an extended time in the chapel.

Music can speak direct to the emotions and can often be a poignant way of reflecting the personality of the one who has died. Most crematoria have internet based sound systems which allow us to provide any piece of commercially released music to be played. We are also able to upload MP3 files containing your own recorded music that can then be played on the day of the service.

Readings and Poems can also be a great source of comfort. There is a vast array of sources, for both religious and non-religious funerals, available online. Family members may even wish to write something much more personal for themselves to read or for the officiant to read for them.

Printed Order of Service sheets are often requested and we are happy to provide these and include a number of favourite photographs to reflect a life well lived. We can also include details of your chosen charity and invite those attending the service for refreshments after the service.

Here are just three of the main choices regarding funeral services.

### Religious Services

The funeral service would be carried out by your local faith leader whether in their Church, at the crematorium or at a cemetery. The service will follow a fixed format, which you will normally only be able to personalise to a certain extent. Your funeral director will arrange for the local leader of your faith to contact you. Where possible they will meet with family members to discuss the service in detail. Often the minister will know the deceased and will be able to reflect this in the service.

A typical order of ceremony for a Church of England Service will include Sentences from Scripture, Hymns, Bible Reading, Minister's Address and a Tribute or Eulogy as well as Prayers including the Commendation and Committal. Family members are welcome to give tributes or readings.

Sometimes families prefer to have a private service at the crematorium followed by a Memorial Service, often at a later date. It is also possible for this service to include the interment of your loved one's cremated remains.

A benefit of this type of service is that the religious leader will normally be able to offer continued pastoral care after the funeral has taken place.

## An Alternative Funeral Ceremony

A ceremony designed to celebrate a life – reflecting the wishes, beliefs and values of the deceased and their family. It is a personal tribute created by a professional civil funeral Celebrant working with you and your family or the funeral director.

A civil ceremony can be held anywhere that is not a religious building. This can be any crematorium, cemetery, green burial site, or you may like to have the service in a hotel or village hall before or after the burial or cremation.

Your funeral director will arrange for a civil funeral Celebrant to contact you, to arrange a convenient time to meet you (at a venue of your choice), to discuss your thoughts and feelings regarding your loved one and your wishes for the content of the ceremony. They will provide you with a selection of readings and offer suggestions regarding music, family participation and, if required, will include any aspect of any religion.

For many this provides a comfortable middle ground that allows them to not only create a service that is a fitting tribute but also acknowledge that there may be mourners at the service who do hold religious beliefs.

The Celebrant will help you to choose the order and content of the ceremony and, based on the information you provide, will write the service including the eulogy.

The service will be unique – a tribute to, and a celebration of, your loved one's life conducted to reflect the wishes of you and your family.

## The British Humanist Association

A funeral ceremony for those who have made a clear decision to live without religion, a humanist ceremony, which uniquely and affectionately honours the life of the deceased.

Humanists care deeply about moral issues, but from a non-religious standpoint. The British Humanist Association has a national network of men and women who are trained and accredited to conduct humanist funeral ceremonies. Their funeral officiants come from a wide variety of backgrounds – what they share is an ability to empathise with the experience of bereavement. They are good interviewers and attentive listeners; sensitive to the family's wishes yet ready to give guidance as needed and able to prepare and take charge of a solemn public occasion. Whatever the circumstances of the life and death, officiants are not there to moralise or judge – but to understand. Together with you they can plan a personal and dignified funeral ceremony and conduct it for you on the day.

It is helpful for the officiant to get to know as much as possible about the person who has died; for each ceremony is different and highly individual, even if the form of it may seem quite simple.

Members of the family or friends can, if they wish, participate with a reading or a poem, or with their own tribute. It all helps make the occasion more personal and special.

Your funeral director can arrange for a British Humanist Association officiant to contact you.

## Life After Death

Losing someone you care about can be one of life's most difficult experiences. There are no easy answers when trying to help a bereaved family come to terms with their loss.

Every situation is unique and people react in different ways.

At A.W. Court we believe we have an important responsibility to care for the bereaved, not just by offering support during the funeral but afterwards as well, especially in the difficult days that may follow. The families in our community are at the heart of what we do.

This section is designed to offer you a brief guide in trying to understand your grief and provide you with details of ongoing support available to you in your community. Whether you need emotional, practical or financial guidance you should be able to find a local professional organisation that have the knowledge and expertise you require. Knowing how to move forward is one of the hardest and biggest challenges we face when we lose a loved one. To enable ourselves to navigate through grief we must first understand what grief is. When we are aware of the unpredictable nature of grief and how it affects us all differently, we can then start to make our own way through it. Each person's experience of grief is as individual as they are. Just as no one person is the same, no one's grief experience is the same.

With this in mind, may we offer you a few suggestions.

## Be Patient With Yourself

The grief process is a time to heal. Coming to terms with the loss and adjusting to a new life does not happen overnight. Grief usually takes longer than most people expect. Do not compare yourself to anyone else or allow anyone to compare you to another situation.

Grieving is a journey. A journey with many 'stop-offs' on the way. Some people's journeys are longer than other's. There is no right or wrong pathway to take. Only what feels right for you. The only thing that is certain is your start point.

By giving yourself time, not by allocating a set time, but by letting go of time, being patient and allowing how you feel, to set your pace, you are 'half-way' there.

## Accept Your Feelings

You cannot choose your feelings. They choose you.

Your emotions may be very raw. You may experience anger, panic, guilt or depression. You may feel other emotions. This is all normal. You are going through one of the most difficult and unpleasant experiences of life.

It is painful and it hurts.



## Ask For And Accept Help

People will say “don’t hesitate to let me know if I can do anything”. Most mean it, so don’t be afraid to ask for help when you need it.

You are not alone.

Talking to those closest to you can be of great support and comfort, enabling you to move forward, together. We also understand that sometimes you would rather talk to someone who is outside of the direct impact of the loss, to help with perspective and clarity. Near the back of this booklet are direct contacts for a range of professional services that are available to help you.

Just ask.

## Take Care Of Yourself

When we are faced with low points in our lives, our motivation can be affected. Taking proper care of ourselves can become easily overlooked. Sleeping may be difficult, but at least try to rest. Nutrition is important, resist the temptation to skip meals or eat junk food. Also recognize that sometimes you may eat to compensate for loneliness or anxiety. Instead, have a walk or a warm bath to feel better.

Don’t torture yourself with regrets and ‘if onlys’. Maybe reading books on grief will help understand what you’re going through.

Do not feel guilty if you have fun, you are not dishonouring your loved one’s memory. Recalling happy or funny memories will help your recovery. Research proves positive emotions produce positive chemical changes in the body.

Hold on to hope and trust that someday this pain will subside and life will have meaning again.

You have begun your journey. Sometimes it may seem the road is too difficult and too long. You may wonder if you will make it.

The answer is:

“You can if you want”.

Although maybe not the answer you expected or wanted, it is a realistic one.

## Conclusion

Every time we experience a loss, we confront a dragon.

We choose whether to slay the dragon or be vanquished by it.

Loss is inevitable, but recovery is optional.

Grief can be a challenging experience, but not more powerful than your ability to work your way through your many emotions.

No one else knows how you feel.

Do not let anyone try to squeeze you into their expectations of what grief should be like.

We have offered these suggestions but only you know the way that is right for you. This is your fight, use every weapon you’re offered, slay the dragon.

## Funeral Poverty

Funerals are getting much more expensive at the same time as support from the government is drying up.

The impact of funeral poverty can be financial, in the form of an unmanageable debt, but it can also be emotional in the form of the distress, shame and the perceived stigma of not being able to provide a 'decent send-off' for someone we love.

### What are we doing to help?

We are one of a few companies that clearly display our prices on our website.

We have taken the time to make our prices as clear and straightforward as possible.

We have a 3 tier price structure to assist families in need of basic funeral services. Our fees start at £1100.00 plus disbursements.

Our professional fee includes everything that is essential to carry out a funeral. Many companies charge extra for the use of the hearse and to effect the removal of the deceased into their care. We believe this gives a misleading figure to families wishing to compare professional fees.

We are also one of the few companies that do not insist on all disbursements and a percentage of professional fees being paid in advance of the funeral. We understand most families don't have a few thousand pounds going spare.

We provide a full written estimate once we have established your requirements. We send the final invoice 7 days after the funeral and allow a further 30 days to receive payment.

Our staff are all paid a salary rather than being commission based.

This ensures there is no incentive for any of our staff to sell you products or services other than those that you want or need.

### Is there any financial assistance available?

#### Bereavement Payment

A Bereavement Payment is a tax-free payment of £2,000. To get Bereavement Payment you must have been below state pension age when your husband, wife or civil partner died, or – if you were over state pension age - they must not have been entitled to state retirement pension, based on their own national insurance contributions, when they died. You must claim within twelve months.

The DWP Bereavement Service can take your claim for bereavement benefits over the phone and do a benefits check to see if you qualify for any other benefits as a result of the death.
